PRIVACY POLICY

1. USER INFORMATION

PROMOCIONES TURISTICAS MEYBRU, S.A., henceforth RESPONSIBLE, is responsible of Users personal information processing and informs you that this information will be treated in accordance with the current legislation of personal information privacy, Regulation (UE) 2016/679 April 27th, 2016 (GDPR) concerning the protection of individuals regard to the processing of personal information and on the free movement of such data, this is why the following information regarding the treatment is provided:

End of treatment: maintaining a business relationship with the User. The foreseen operations to this treatment are:

- Sending commercial advertising communications, whenever previously authorised, via e-mail, fax, SMS, MMS, social network o any other electronic or physical means of communication, present or future, allowing business communications. These communications will be carried out by the RESPONSIBLE and related with their products and services, or with their collaborators or suppliers with whom a promotion agreement has been achieved. In this case, third parties will never have access to personal information.
- Carrying out statistical studies.
- Handling orders, applications, or any other kind of petition made by the user through any of the available contact methods.
- Sending the web page newsletter.

Data conservation criteria: it will be kept while there is a mutual interest in maintaining the end of treatment and when there is no need for this purpose, they will be deleted through appropriate security methods to guarantee data pseudonymisation or its total destruction.

Data communication: information will not be shared with third parties, except because of legal obligation.

User's rights:

- Right to withdraw the consent at any time.
- Right of access, rectification, portability and data suppression and limitation or opposition of its treatment.
- Right to file complaint to the authority of control (agdp.es) if it is considered its treatment is not adjusted to the current regulations.

2. COMPULSORY OR OPTIONAL NATURE OF THE INFORMATION PROVIDED BY THE USER

Users, through checking the corresponding boxes and entry data in fields marked with an asterisk (*) in the contact form or in downloadable forms, specifically accept freely and unambiguously, that their information is needed to answer to their petition, by the service provider, being optional filling the remaining boxes. The User guarantees the information given to the RESPONSIBLE is true and make themselves responsible to communicate any change in them.

The RESPONSIBLE informs and specifically guarantees the users that their personal information will not be shared in any case to third parties, and that whenever these are shared, the specific allowance will be asked, informed and unambiguous from the Users. All the information requested via the website are obligatory, as they are necessary for the provision of optimum service to Users. In case not all the information is provided it is not guaranteed that the information and services provided are completely adjusted to their needs.

3. SECURITY MEASURES

In accordance with current legislation of personal information privacy, the RESPONSIBLE is fulfilling all the GDPR regulations and rules to process personal information of its responsibility, and clearly with the principles stated in the article 5 of GDPR, which are fairly, lawfully and transparently processed in relation to the interested and adequate parties, pertinent and limited to what is necessary in relation to the purposes for which they are treated.

The RESPONSIBLE guarantees that has implemented appropriate political and organizational techniques to apply security measures established by the GDPR in order to protect the User's rights and freedom who have been communicated with the proper information, so they can exercise them.
